OVERVIEW

Comprising functional and technology leaders from across campus and ITS, this group meets six times a year to plan and discuss IT operations, opportunities, strategies, and innovational directions.

OBJECTIVES

The TIC provides strategic oversight for the Technology Operating Committee (TOC) and the IT operating and strategic plans.

The TIC will review and propose a comprehensive technology portfolio including teaching, learning, research, and administration to the University Officers.

The objectives of the TIC are to

- Review progress of the portfolio, changes made to the portfolio, ensuring alignment with overall portfolio objectives, university mission and university and technology strategies
- Make recommendations of fiscal year portfolio allocation investments to the University Officers
- Review and approve proposals over \$250K, re-balance the portfolio and confirm priorities
- Update the University Officers bi-annually on portfolio progress.

RESPONSIBILITIES

The TIC receives regular reports from the IT Strategic Committees on technology needs, ideas, and issues facing the university community. These thoughts and comments are collected and analyzed for consideration.
